Costs The volunteer will cover most associated costs. In many cases

the partner is able to cover costs such as accommodation, airport pickup, meals, visas and vaccinations. Assignment options will always be created to closely match your budget and information regarding all associated costs will be made available.

Flights and accommodation costs will always be covered by the charity.

In some cases other associated costs will be covered and an allowance provided.

Check website listings for the expenses covered on each assignment.
